Agreement for use of grounds and equipment 2022

Must be signed by all riders. For riders under 18, a parent or legally authorised guardian must sign.

WARNING: This is a legal document that affects your rights. If you do not understand it consult a lawyer before signing.

I agree to participate in this agreement on the following basis:

RISK AND INJURY

1. I acknowledge that equestrian events involve the real risk of serious injury and/or death. This includes injuries or death related to or resulting from pre-existing disabilities or medical conditions.
2. By agreeing, I accept all risks necessarily flowing from my use of grounds and equipment, which could result in loss of life, temporary or permanent injury. Accordingly, I release all people associated with the grounds and equipment and will indemnify them (to the extent my actions are not excused or protected by law) against all liability (including liability for their negligence) for all injury, loss or damage arising out of or connected with the grounds or equipment. For clarification, the people released include event organisers, promoters, sponsors, managers, Pony Club Queensland Inc and the promoters, sponsors, managers the Jimboomba Pony Club Inc, (Jimboomba Pony Club) and all of their respective directors, officers, employees, agents, contractors and volunteers including event medical and paramedical personnel. This release and indemnity continues forever and binds my heirs executors, personal representatives and assigns.
3. I acknowledge that safety precautions undertaken by or on behalf of Jimboomba Pony Club are a service to me and other members but are not a guarantee of safety.

- 4. Horses/ponies are ridden by me at my risk. Jimboomba Pony Club is not responsible for injury, loss or damage resulting from animal behaviour (including behaviour caused by the presence of other animals or members).
- 5. I acknowledge that neither the Jimboomba Pony Club Inc nor Pony Club Queensland Inc accepts any liability for any accident, damage, injury or illness to horses, riders, grounds, spectators, or any other person or property whatsoever.

GROUNDS AND EQUIPMENT RULES

- 6. Jimboomba Pony Club grounds are only to be used in daylight hours, when no organised event or clinic is being held, unless approval is provided by a member of the Jimboomba Pony Club Management Committee.
- 7. Grounds are not to be used when they are closed for maintenance or being prepared for an event
- 8. The dates and times that the grounds are hired or closed will be published on the Jimboomba Pony Club Website
calendar. (www.jimboombaponyclub.com.au/calendar) It is the responsibility of grounds hirers to check whether grounds are available prior to use and to ensure that they have access to our website for these messages. Separate calls/sms/paper mail advice will not be issued
- 9. Grounds may be used on the same day after an organised event is finished but grounds should not be entered prior to advice being posted on Facebook that the grounds are available.

10. Grounds hirers must not permit any other person who is not a financial grounds hirer or financial riding member of Jimboomba Pony Club to ride any horse that the hirer is in control of while on the Jimboomba Pony Club grounds.
11. Grounds access must not be provided to any rider who is not a financial grounds hirer or financial riding member of the Jimboomba Pony Club. Key codes must not be provided to unauthorised persons.
12. Upon arrival and prior to unloading any horses, a completed “Jimboomba Pony Club Horse Health Declaration” must be placed in the letterbox beside the front gate. Copies are not provided at the club house and riders must bring completed paperwork with them. Electronic copies can be found on our website.
13. Entry gates are to remain closed. Entry gates must be locked upon exit unless there are other riders still on the grounds.
14. No rider is to bring their own sporting or jumping equipment to the grounds without prior approval of a member of the Jimboomba Pony Club Management Committee.
15. **All riders must wear approved safety helmets of a standard: AS/NZ 3838, ATSM F1163, VG1 or better** when mounted and Pony Club Queensland Approved footwear must be worn by anyone riding or handling horses.
16. If riders notice any broken equipment or damages to any property on the grounds the rider is to advise a committee member. Contact details are provided at the end of this form or via facebook messenger.
17. All equipment is to be put away appropriately and in a safe manner.
18. All horse manure and hay must be removed from the yards after use and placed in the designated manure pile. Jimboomba Pony Club has provided the equipment to do this and riders must ensure that they bring manure removal equipment back to the front of the indoor arena.
19. Horses must not be tied to any Jimboomba Pony Club fence or fixture other than yard fences. Horses tied to yards must be soft tied (to bailing twine).
20. Rubbish is not to be left anywhere on the grounds. Please place any rubbish in the bins at the front gate.
21. All gates must be closed whilst riding or whilst horses are on Jimboomba Pony Club Grounds.
22. Jimboomba Pony Club is on tank water and horses are not to be washed at the grounds. Water is available from the green tank near the shed.
23. Amenities (Toilets) are not left open. Access may be arranged with prior notification.
24. The Jimboomba Pony Club Biosecurity Plan Must be followed in the event that a biosecurity hazard is identified. If a horse becomes sick on the grounds or after attending the grounds a management member must be notified immediately (Contact details at the bottom of this form).
25. No stallions are permitted
26. Jimboomba Pony Club can revise and amend the ground’s use and fees at any time.

INDOOR ARENA RULES

27. A maximum of 5 riders are to ride at one time in the arena unless part of an authorised event or other authorised by a member of the Jimboomba Pony Club management committee.
28. During peak periods (this may include wet weather, wet grounds or extreme heat) if there is a queue for the indoor arena, riding time in the arena is capped at 30 minutes per horse.
29. The arena must be used fairly. Riders deemed to be using the indoor arena excessively may have further fees applied. Excessive use could include multiple horses being ridden Multiple days per week.
30. No sporting, Sliding or galloping to occur in the indoor arena
- 31. All horse manure must be removed from the indoor arena - Using the forks and bins provided.***
32. No Equipment is to be placed in the indoor arena without prior approval of a Jimboomba Pony Club management committee member
33. No horse is to be tied to the indoor arena fence (either hard or soft tied).
34. Indoor arena gates must be kept closed except when horses are entering or exiting.
35. No lunging in the indoor arena.
36. The Jimboomba Pony Club Management Committee can revise arena rules at any time.
37. No one except instructors and parents should be unmounted in the indoor arena.

ACKNOWLEDGEMENT

38. I agree to abide by all rules and directions issues by members of the Jimboomba Pony Club Management Committee either verbally or in writing.
39. I agree to abide by all rules and directions on this form.
40. I certify that I am 18 years of age or older and I have read this document and fully understand it.
41. I acknowledge that my use of the grounds may be monitored by Close Circuit Television (CCTV) or similar devices.
42. I Understand that as a grounds hirer I am not a member of the Jimboomba Pony Club Inc.
- 43. I understand that non-adherence to the above conditions may result in immediate forfeit of my access to the Jimboomba Pony Club Grounds, and no refund of hire fees will be issued.**
44. I am liable for any costs associated with damages to Jimboomba Pony Club or Logan City Council Property that occur as a result of my (or my parties/related persons) non compliance with the above conditions. I will pay any such costs within 30 days of an invoice being provided to be my Jimboomba Pony Club.

45. I understand that the period of hire is from **1st July 2022 - 31st December 2022**
